**CALL MEETING TO ORDER:**

Pres. Mengel called the recessed meeting to order at 7:13 P.M.

**UNFINISHED BUSINESS FROM PRIOR MEETINGS:**

**Adopt Ordinance No. 736 Pertaining to Revisions to the Pension Agreement for Part-time Employees** – Solicitor Cravitz reported that this was given to the Borough by the State concerning part-time employees. It also authorizes Mgr. Bickhart and Pres. Mengel to sign the pension plan agreement. The Ordinance states that membership in the Pennsylvania Municipal Retirement System shall be mandatory for all full-time municipal employees of the Borough. Membership for elected officials, part-time employees and employees hired on a temporary or seasonal basis are prohibited as is membership for individuals paid on a fee basis. Therefore all part-time and seasonal employees, John Coukart and Solicitor Cravitz are excluded from having membership in the Borough's pension. The rest of the Ordinance is boilerplate language required by the State Municipal Retirement System. C/P Kinney asked why this was done and Solicitor Cravitz replied that in the Borough's previous Ordinance part-time employees were included.

Motion by C/P Kinney to adopt Ordinance No. 736. Seconded by C/P Hetherington. Pres. Mengel called for a vote on the motion.
