INVITATION FOR BIDS

The Borough of Selinsgrove will accept sealed bids for the "2020 Street and Alley Program" until 10:00 AM, (Prevailing Time) May 26, 2020 at the Selinsgrove Borough Office, One North High Street, Selinsgrove, Pennsylvania 17870, at which time and place all Bids will be publicly opened and read aloud.

Bids are invited upon the following:

The project is located along Susquehanna Avenue from Spruce Street to Snyder Street, Blackberry Alley from Broad Street to Charles Avenue, and Pump House Alley from Spruce Street to Chestnut Street. The work to be performed includes the resurfacing of approximately 2,474 square yards of bituminous roadway, 1,032 square yards of bituminous patching, and related items of work as indicated in the contract documents.

All work shall be performed in accordance with the Contract Documents prepared by Coukart & Associates, Inc., 500 Vine Street, PO Box 300, New Berlin, Pennsylvania 17855, telephone number 570-966-2860.

The Contract Documents are on file and may be examined at the office of the Borough during regular business hours, 8:30 AM to 4:30 PM, Monday through Friday, with a prior appointment.

All bidders are required to have current Pennsylvania Department of Transportation Subcontractor pre-qualifications for all major items of work in the contract at the time of bid submission and throughout the length of the project.

A satisfactory Bid Bond executed by the Bidder and an acceptable surety, in an amount equal to ten percent (10%) of the total Bid, shall be submitted with each Bid. The Bidder shall include the fully completed Non-Collusion Affidavit with the bid.

The bidders' attention is called to the fact that not less than the minimum salaries and wages, as set forth in the Contract Documents, must be paid on this project and bids shall be prepared accordingly. The applicable prevailing wage predetermination is included in the Contract Documents.

The Owner reserves the right to waive any irregularities in the bids or bidding and to reject any/all bids or to waiver any informalities in the bidding.

Bids may be held by the Owner for a period not to exceed 60 days from date of opening for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding the Contract.
